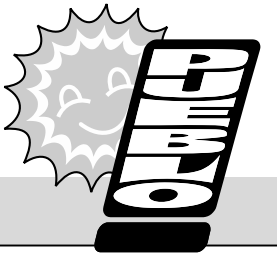

PERSPECTIVE by Jon Heaton, Tribune editor

Seymour Hirsch, that rascally writer for the *New Yorker* magazine whose Pulitzers go clear back to Mi-Lai, has now written that Georgie, Dickie and their Neocon cronies have launched a new plan to go after Iran. This time they're zeroing in on Iran's elite Islamic Revolutionary Guard (IRG), which they last week put on our list of Terrorist Organizations. The IRG is believed to be an independent force in Iran because its favored status has enabled it to finance its operations through ownership of lucrative commercial interests.

Hirsch says he got the tip-off from Pentagon insiders who are afraid the White House might actually get away with pursuing this hair-brained scheme to attack IRG facilities. Still unwilling to admit even one iota of blame for their Middle East debacle, the Cheney Gang has got Georgie dreaming new dreams of victory by expanding their Middle East war.

Hirsch reports that the Iran attack will depend on the new Chairman of the Joint Chiefs, Admiral Mike Mullen's Navy pilots and missiles, which are already in position to make a quick strike, purportedly at the IRG "terrorist branch" of Iran's military. While first appearing to Americans to be "limited" and "targeted," the Cheney Gang figures this first strike will rapidly expand into all-out bombing, which the Gang fantasizes will bring the latola to his knees...or at least subdue him.

As usual, the Cheney Gang has decided to ignore reality in favor of another fantasy of world conquest. Admiral Mullen, who just took the reigns at the Pentagon, wants to get his more or less sidelined Navy into action, so he's hot to pursue this new Cheney-Neocon plot.

If these nuts can get us committed to an expanded regional war before they leave office in 16 months, they believe the next President will be locked into this

mess. Once we're involved in a conflict with Iran, it will be even more difficult to extract our forces from the Middle East. Thus, we will be drawn one more step closer to a World War.

What boggles the mind is the immense stupidity and cynicism required for our present leaders to believe this militaristic course toward world domination is both realistic and achievable. Our leaders actually see this war against terrorists as a way to grab control of all petroleum resources in the Middle East and Africa.

The Cheney Gang's goal, ultimately, is to curtail China's access to oil resources, while enhancing ours. But if the Gang succeeds, China will probably turn to an alliance with oil- and gas-rich Russia. Now that China has got the hang of mass industrial production, a Russo-Chinese Axis might be capable of attempting to dictate the future of the debt-ridden Western Powers.

A Better Way...

Bush and the Cheney Gang believe military action is the solution to every international problem. We can be certain of this because they consistently call for more military appropriations but demand spending restrictions or cuts for virtually all other programs.

The result of this militarism is the need for more and more of the same, because the prescription to fix every failure is even more military spending. The failures are bound to occur because the history of war is a long litany of mind-boggling mistakes which almost always result in the obscene waste of lives and treasure.

As we watched Ken Burns' *The War* last week and this, we couldn't help being struck by the many stupid decisions our commanders made. From McArthur, Eisenhower, Patton and Clark, right on down to field officers, stupid ideas resulted in the slaughter of tens of thousands of our own soldiers and sailors. This was also true in the First

World War, as well as in Korea and Vietnam. When a leader rushes to war, it's a sure sign he is either stupid or mentally ill.

Defense of the nation can be justified but "preemptive" military actions are almost always plain old armed aggression. Tyrants usually manufacture a good reason for their aggressions, but Bushy has come up with half a dozen reasons for his invasions, with each new one being offered to take the place of the latest reason that has proved to be an outright lie.

The biggest problem with war is idiots – the sick psychos who start wars and then the arrogant idiots who run them. Those born with a pernicious callousness seem to rise to the top in war. Their cure for every atrocity seems to be another, more savage atrocity.

The better way is to always avoid open warfare except as a true defense of the nation, its population and its allies against an aggressor. And force should be proportional to, and of a nature appropriate to, the threat. For example, employing classic warfare to oppose a guerrilla force is wasteful and ineffective because its tactics result in great harm to civilians while its sheer size telegraphs all its operations to the enemy.

We can't say it too often: Bush chose open, classic warfare so he could invoke the powers of Commander in Chief to disguise his extra-legal acts, both foreign and domestic. Only the belligerent jingoism and hate-mongering of their supporters has, so far, been sufficient to protect Bush and the entire Cheney Gang from impeachment or jail.

To put it bluntly, the Democrats and moderate Republicans hesitate to challenge the Bush-Cheney War Oligarchy for fear they will be branded unpatriotic and weak. This writer believes it would be both rational and honorable to clip the Bush-Cheney Gang's wings.
