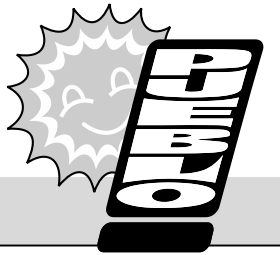

Whooping Cough in Pueblo:

Pueblo County Health Urges Vaccination, Timely Diagnosis

PbloHealth 8/4 – On Wednesday, Public Health officials in Pueblo announced two pertussis (whooping cough) cases in Pueblo youth. These two cases are not related. The youth are being treated as the Health Department investigates the possible spread of illness to additional people.

“Parents are urged to make sure their child is up to date with their childhood vaccines,” stated Jody Carrillo, RN, Director of the Disease Prevention and Emergency Preparedness Division at the Pueblo City-County Health Department. She added, “this is a highly contagious disease.”

Adults should know that they can help to protect children and infants against the disease by getting vaccinated themselves. Research shows that half of the babies infected with pertussis are exposed by their parents, while 90% of unvaccinated children living with someone who has the disease can become infected. Vaccinations are available through doctors or by calling the Health Department clinic at 719-583-4380.

“Adults with a nagging cough must get checked by a doctor, as they can expose so many other people to the illness, es-

pecially individuals who are unvaccinated or too young to get vaccinated,” stated Carrillo.

CDC reports through July 2010, several states have reported an increase in cases and/or localized outbreaks of pertussis, including a state-wide epidemic in California. Localized outbreaks are not uncommon and occur throughout the year. Over the last five years, 8,000-25,000 cases of pertussis were reported per year in the United States. Everyone should make sure they are up to date with pertussis vaccinations — DTaP vaccine for infants and children and Tdap booster for adolescents and adults.

Carrillo called on doctors and other healthcare providers in Pueblo to assist the local health department in controlling the spread of this disease by promptly reporting suspect cases. Those with pertussis and their close contacts should be treated with antibiotics.
