toric character. Original energy conservation features of the school will be restored and appropriate new energy-saving technologies will be sensitively integrated.
The San Juan County Historical Society will be repairing a failing water supply pipeline and installing a micro-hydro turbine to produce electricity to offset the Society's electricity bills at the National Historic Landmark Shenandoah-Dives Mill. A century ago, mills all over the San Juan area were powered by hydro-electric power. Once completed, the project will provide an added attraction to summertime tours of the Mill, enhance fire protection and serve as a regional model for installation of micro-hydro power.
