# Prescribed burns planned to improve habitat, reduce fuels

ColoParksWild 10/30–Recent favorable weather conditions are allowing multiple agencies, including the U.S. Forest Service, to conduct prescribed burns in areas across the state. Access to some hunting areas on public lands may be limited while the prescribed burns are taking place, and Colorado Parks and Wildlife is advising hunters to seek information from the appropriate landowners before heading out into the field. Colorado Parks and Wildlife also wants to remind the public that fires are a natural occurrence in nature and many plants and animals benefit from the changes a fire brings.

Colorado Parks and Wildlife is working with these agencies to try to reduce the impact of the prescribed burns to hunters as much as possible. However, finding the right window for a safe, effective burn can be tough.

The U.S. Forest Service's next prescribed burn is scheduled to take place at the end of this week, weather permitting, in a small portion of a Game Management Unit 511 outside of Colorado Springs. The burn will take place about nine miles north of Woodland Park off Highway 67.

"When possible we try to schedule these fires around hunting seasons, but we are limited by Mother Nature and must take advantage of opportunities that present themselves," said Eric Zanotto, Fire Management Officer with the U.S. Forest Service

There will also be prescribed burns occurring near Lake George. For more information or questions about these burns, contact the USFS at 719-636-1602. For questions about other prescribed burns in other areas, contact the local USFS office. Very specific conditions need to be in place for a prescribed burn to take place. These conditions generally occur in spring and fall, when temperatures are moderate and humidities are higher at night. Biologists stress that fire is an important tool for improving wildlife habitat. Fire opens dense stands of oak brush and mountain shrubs, improves nutrients in the soil and food is more palatable to wildlife in its new growth state.

"Prescribed fire can really benefit many species of wildlife including big game in Colorado," said Senior Wildlife Biologist Brian Dreher. "Compared to the catastrophic fires that we have seen in the last few years, prescribed fire tends to burn with lower intensity, which facilitates quick regeneration of plants desirable to big game."

# FREE FIREWOOD GATHERING AT LAKE PUEBLO STATE PARK

LakePblo 10/23) — As winter nears, Lake Pueblo State Park is again allowing visitors to gather firewood within the park boundaries as well as offering a new opportunity to collect firewood from the Valco Ponds area.

Between Nov.1 and Nov. 30, driftwood found along the shorelines may be taken for personal use by acquiring a free permit. No other wood, including limbs and branches on live or dead standing trees, may be gathered.

Newspaper Assn. The permit and a park pass are required to collect firewood inside the park. A limited number of firewood gathering permits are available and can be found at the Park's Visitor Center between 9 a.m. and 4 p.m., seven days-a-week. The permits will be issued on a first-come, first-serve basis. There will be only be 30 permits issued, so please call ahead to check availability. Each permit will include a map that shows where the wood may be gathered.

Lake Pueblo State Park is also offering the free collection of firewood in the Valco Ponds parking lot area for the first time this year. No parks pass is required for this area but collection of firewood will be limited to the following dates and times:

Saturday, Nov. 1: 8 a.m. - Noon Sunday, Nov. 2: Noon - 4 p.m. Saturday, Nov. 8: 8 a.m - Noon Sunday, Nov. 9: Noon - 4 p.m. Those interested in collecting wood from the Valco Ponds area should meet park staff at the gate at the west end of the Valco Ponds parking lot, off Highway 96. Staff will provide directions to the collection area. No trailers, please, as the collection area has limited turn-around points.

# CPW issues reminders for fall boating

ColoParksWild 1/31-Colorado Parks and Wildlife's Boating Safety Program reminds boaters to take precautions to protect themselves from heightened dangers of sudden, unexpected cold water immersion while on late season boating outings, especially on small boats.

"As the days grow short this autumn and water temperatures take a dip, hunters, anglers, paddlers and all boaters must be aware of the risks of cold water," said CPW Boat Safety Coordinator Kris Wahlers. "Hunters, paddlers and any boater on the water can take precautions and prevent being suddenly thrown overboard, swamped or stranded in cold water."

Sudden immersion in cold water can cause gasping and inhalation of water and hypothermia, resulting in unconsciousness or swimming failure as muscles become numb. Wearing a life jacket will keep your head above water and support your body should your swimming ability fail or you become unconscious.

CPW officers have noticed a lot of people overestimate their ability to 'swim out of a problem,' because of this CPW recommends anyone out on the water wear a life jacket though state law only requires life jackets be worn by anyone under the age of 13.

CPW recommends the following to boaters heading out on the water this fall:

 Always wear a properly fitted life jacket. A life jacket will help keep your airway clear of water and keep you floating if you start to numb. (It happens a lot faster than you may realize.)

 Dress for the weather. Consider wetsuits or layer your clothing to reduce loss of body temperature should you end up in the water;

• Avoid boating alone, but in any case let someone know where you are going and when you expect to return.

 Bring a cell phone or VHF radio, in a watertight bag, should you need to call for help;

 Properly equip and carry essential safety gear, signaling devices and whistles;

• Don't use alcohol, and

 Bring something along to help you get back in your boat in case you fall out.

Finally, CPW recommends that all boaters take a boating safety class. In Colorado, everyone 14 and 15 years of age must pass a CPW boating safety course before operating any kind of powered vessel, including personal watercraft.

Regardless of age, it's important for everyone to take a boating safety course. In 2013, 88% of operators involved in a boat accident had no known boat safety education.

Seventeen fatalities in Colorado were associated with recreational boating in 2013. The only fatal boating accident on a lake directly involved not wearing an life jacket. The Coast Guard estimates that 80% of all boating accident deaths might have been prevented had a life jacket been worn.

Should you ever find yourself in the water it is recommended that you stay with - and preferably on top of - your boat. Also consider bringing along a way to get back in your boat, such as a ladder, a knotted rope or at least a plan. Cold muscles and wet clothes make it very difficult to get over the side and sometimes even the back of a

Never overestimate your swimming ability. All too often people underestimate the distance to shore or the effects of cold water and unfortunately drown while attempting to make it to safety.

"Knowing the risks of cold water and taking the right precautions will save your life," added Wahlers.

The CPW Boating Safety Program is responsible for the general coordination of boating safety programs and supports marine law enforcement efforts across the state, including patrols, training and funding for local marine enforcement activi-

# How to fix five sources of energy waste in your home for less than \$20

BlackHills 10/24) - During Energy Awareness Month, Black Hills Energy is suggesting smart, cost-effective fixes many costing less than \$20 for Southern Colorado residents to overcome five common sources of energy waste in cold weather months.

"Nearly half of all energy use during the colder weather months is dedicated to heating homes, according to the Environmental Protection Agency," said Jill Linck, Energy Services Division for Black Hills Energy. She suggests simple ways to increase heating efficiency in their homes, as well as to check other, less obvious sources of energy waste, including appliance use:

• Air leakage: Air leakage occurs when cold outside air enters and warm air escapes



through cracks and openings, increasing the cost of keeping a home at a consistently comfortable temperature. Feel for leaks by floating your hand around the perimeters of doors and windows, electrical outlets, and even cable and telephone line entry points, then seal any problem spots using caulk and a \$5 caulking gun. Adding weatherstripping to doors and windows is another low-cost way to keep the winter chill out and the warm air in.

• Dirty air filters: Dirty furnace air filters can clog and cause higher resistance of air flow, particularly during highusage months, resulting in more energy consumed. Diligent cleaning of air filters each month for about \$20 with filter spray and oil, and replacing them about every three months keeps warm, clean air flowing in throughout a home.

• Kitchen culprits: It's hard to resist opening the oven door to check on baking cookies or a Thanksgiving turkey, but did you know the temperature inside an oven drops 25 degrees every time the door is opened while in use? This increases cook time and wastes energy. Instead, turn on the oven light for a peek inside. When using the stovetop, use the right-sized pot or pan for each burner – for example, a six-inch pan on an eight-inch burner wastes 40 percent of the burner's energy.

 Duct leaks from the furnace to the vent: HVAC ducts that leak conditioned air into unheated spaces can add hundreds of dollars a year to heating and cooling bills. Sealing seams with duct mastic means a furnace doesn't have to work overtime to keep your family cozy. Duct mastic is available for under \$15 per gallon, and can be applied with an inexpensive paint brush.

 Thermostat control: Adjusting a thermostat down 5 degrees to 10 degrees while you're asleep or while you're out of the house can help you save on heating and cooling bills, according to the U.S. Department of Energy. Utilize programmable thermostats for when you're typically out of the house, too. In general, a good rule of thumb is to keep the thermostat set to 68

"Taking proactive steps to increase a home's energy efficiency is one of the quickest, most costeffective ways to address energy consumption during Southern Colorado's colder weather months," Linck said "In addition to simple in-home fixes they can do on their own to reduce energy waste during this time of year, we encourage them to apply for one of our residential energy efficiency programs or connect with us to find out if they qualify for our Low Income Weatherization program."

# Viewing Political Corruption More Broadly

Earlier this year, veteran political writer Thomas Edsall reported an eyebrow-raising fact about Americans' views toward government. Polling by Gallup, he noted, found that the proportion of Americans who believed that corruption is "widespread" in government had risen from 59 percent in 2006 to 79 percent in 2013. "In other words," Edsall wrote, "we were cynical already, but now we're in overdrive."

Given the blanket coverage devoted to public officials charged with selling their influence, this shouldn't be surprising. Former Virginia Gov. Bob McDonnell and his wife were convicted last month of violating public corruption laws. Former mayors Ray Nagin of New Orleans and Kwame Kilpatrick of Detroit were good for months of headlines. So were Republican Rep. Rick Renzi, convicted last year on influence-peddling charges, and Democratic Rep. Jesse Jackson Jr., who pled guilty to charges of misusing campaign funds.

If you add state and local officials who cross the line, it might seem that we're awash in corruption. Yet as political scientist Larry Sabato told The New York Times, that's more perception than reality. "I've studied American political corruption throughout the 19th and 20th centuries," he said, "and, if anything, corruption was much more common in much of those centuries than today."

Nor have the numbers over the past couple of decades risen. In 1994, according to the Justice Department's Public Integrity Section, 1,165 people were charged in public-corruption cases, of whom 969 were convicted. Last year, 1,134 were charged, of whom 1,037 were

Corruption is hardly a negligible issue. Americans rightly have very little tolerance for public officials who are on the take. Officials who violate the law in this regard should face criminal prosecution and incarceration.

But what's notable about our corruption laws is how narrow they've become. This point is driven home by Fordham Law School Professor Zephyr Teachout in her new book, Corruption in America. "As a matter of federal constitutional law," she writes, "corruption now means only 'quid pro quo' corruption." Prosecutors today have to prove an intentional exchange between "briber" and public official, in which the official receives a benefit for taking

Teachout argues that our Founders were quite resistant to public behavior promoting private interest. She quotes George Mason, for instance, arguing against giving the President the power to appoint key officials: "By the sole power of appointing the increased officers of government," Mason insisted, "corruption pervades every town and village in the king-

As late as the second half of the 1800s, American society was alarmed by the notion that private individuals might seek to influence government on their own or others' behalf. "If any of the great corporations of the country were to hire adventurers... to procure the passage of a general law with a view to the promotion of their private interests, the moral

sense of every right-minded man would instinctively denounce the employer and the employed as steeped in corruption," the Supreme Court declared in 1874.

We have another word for "adventurers" these days. We call them lobbyists.

Americans remain uncomfortable with "corruption" as our forebears viewed it. A hefty majority believe that government is run on behalf of a few big interests. And Congress, whose ethics committees have not been rigorous in looking for misconduct that brings discredit on their chambers, has contributed to that view.

I would hardly contend that all who seek to promote their private interests are corrupt. But I do think the Founders had a valuable insight when they saw that a focus on private concerns could lead to neglect of the common good.

I have the uneasy feeling that too many politicians are self-absorbed, failing to put the country first, and using their office to promote their private interests. Our Founders had very firm ideas about the importance to the nation of "virtue" in a public official — and they were thinking expansively about the basic standards of public accountability.

Maybe it's time we looked to them for guidance, and not think of corruption only in the narrow sense of violations of specific laws or precepts, but more broadly in terms of failing to pursue the common good.
